Kibali kimetolewa kwa Kampuni binafsi ya **Eyesight Security Enterprises Company Limited**, iliyopo Mkoa wa Kinondoni - **Dar es Salaam** kuendesha shughuli za ulinzi binafsi.

Unatakiwa kutekeleza na kuzingatia mambo yafuatayo na kutujulisha ili tufanye ukaguzi kabla ya kuanza kazi, na wakati wote unapoendesha shughuli za ulinzi binafsi.

1. Hakikisha kwamba askari/walinzi utakaowaajiri wawe ni watanzania ambao hawana rekodi zozote za uhalifu. Kwa maana hiyo itakubidi kwanza kabla ya kuajiriwa kwao wachukuliwe alama zao za vidole na kutumwa Makao Makuu ya Jeshi la Polisi (Kamisheni ya Uchunguzi wa Kisayansi, Makao Makuu ili kuhakikisha kwamba hawana rekodi zozote za uhalifu.
